

BOARD BRIEFS AND COMMUNITY NOTES

The Board Briefs are a brief overview of the BOD meeting. Click here to refer to the board packet and committee reports for more complete information.

GENERAL MANAGER: The Board approved the GM's request to proceed with the collections process of any outstanding 2023 unpaid assessments.

SECURITY: The Director of Security clarified the Pet Policy, "all dogs must be on a physical leash and under the direct physical control of a person when not on the property at which its owner is residing. Definition: The dog must be under physical control, on a leash, with the leash in the hand of the owner and in control.

FACILITIES: Philip Square, Facilities Manager, presented to the Board an approximate cost (\$113, 422.00) per year to move and maintain the bike path trash receptacles to the beach side. The Board agreed not to spend money this year to move the receptacles.

The Board also agreed by a vote 4 to 3 to postpone the Magnolia Pool resurfacing repairs for 1 (one) year.

The construction of the Resort Village Bayside dock/kayak launch will begin at the end of March.

AUDIT: Kevin Bowyer of Warren Averett reported,"In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Association as of December 31, 2022, and the results of its operations and cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America" In consideration of the auditor's opinion, the Board passed the motion that the Board approve the 2022 Audit as presented by Warren Averett with the exception of one minor narrative related change.

FinCom: The Committee recommended to the Board that no new transfers to the Capital Improvement fund be made in 2023 until Reserve Maintenance and costs are better understood.

The Board approved Jim Mott to be Vice-Chair of Finance Committee and Leo Korpanty as a FinCom committee member.

New Website, New Owners Portal, Now What?

The long awaited and mobile friendly Plantation website, developed by KMA of Mexico Beach, FL, launched on March 1st. The new Website (www.sgpoa.com) has all the same information as the old website and is more user-friendly.

In addition to the public Website, a new owners portal is powered by FrontSteps, a software company

specializing in HOA communities. Within the portal, owners can access SGPOA documents, meeting

information, and Community information, including newsletters, bulletins, activities, etc.

The following steps are needed to access the **Owners Portal**:

• Owners should have received an email invitation (see above) from FRONTSTEPS to register. The *i*nvitation was sent to the email address on file. Please check your spam or junk folder if you did not receive the email. Contact office@sgpoa.com as soon as possible if your email needs to be updated in our records.

Registering is required to access the Owners' Portal. You will need an email address and create a password requiring at least one capital letter, one number, and one non-alphanumeric character (!,@,# etc.)

To include your phone number and email information in the directory, you must "opt in".

Go to settings in the upper right-hand corner and click Privacy Settings. Check the corresponding box if you want emails, phone numbers, etc., visible in the directory.

Once registered, you can access FRONTSTEPS via the new Website www.sgpoa.com. The Owners Login button, located at the top right of the Home page (see photo above), will take you directly to the Owners' portal, FRONTSTEPS.

To enter guests: Dwelling Live (for guest passes) is found in two places on the SGPOA Home page. Look for a portal button at the bottom right of the new SGPOA website Home page or in the top menu bar click LIVE (see photo above for menu bar) for a drop down menu, then click Dwelling Live to access the Dwelling Live portal. **Dwelling Live login information has not changed. Please do not call the gate to register guests.**

***Please note: The Owners portal and the new Website are a work in progress. There will be changes and additions daily. Please check back frequently and inform the office of helpful changes or updates.

Sikes Cut Nesting Area Now Posted

In early March, an energetic Plantation volunteer group joined Audubon personnel at Bob Sikes Cut to stake the area for nesting shorebirds. Before Hurricane Michael in October of 2018, Snowy Plovers nested here. Oyster catchers have recently been sited there, and Least terns may use the area as a nesting site. Both bird species are of statewide concern due to diminishing nesting sites, so providing and protecting a haven for nesting is essential. Sikes Cut is a popular spot to fish, beach comb, and enjoy the island's natural beauty. Although dogs must be leashed, please maintain a reasonable distance from the staked area as the birds will assume all as predators. If you see others walking too close to the nesting area, take the opportunity to share information about the significance of the staking and the importance to the ecosystem in bringing these birds back to the area. We can coexist by helping these birds re-establish nesting grounds and share the natural environment that surrounds us.

In the Plantation we are all stewards of this area. If anyone sees bird activity in the staked area or any signs that need repair, please take a picture and email it to Dr. Stahala: Caroline.stahala@audubon.org.
