Friends, neighbors, and visitors,

Memorial Day marks the start of the traditionally busy summer season here on St. George Island. I look forward to the excitement of first time visitors to the island and the Plantation along with the homecoming of those who have been visiting for years, often times decades. As the season is

just getting started I want to take this opportunity to provide a couple of reminders.

The first reminder is for the Pet Leash Policy. All dogs must be on a physical leash and under the direct physical control of a person when not on the property at which its owner is residing. That means a pet must be physically connected to it's human by a leash. As this is an official policy of the SGPOA, any offenses are subject to verbal, written warnings and possible citation by our security staff.

My second reminder is regarding fishing, specifically fishing from the shore. A couple of things here: fishermen and swimmers are often in close proximity. So for everyone's safety please give each other plenty of room to enjoy each activity. The other is in regards to shark fishing from the shore. This activity is subject to Florida Wildlife Commission rules and regulations. While shark fishing from the shore is legal, please be especially respectful to the presence of swimmers whether adults or children. Lastly, chumming for sharks from shore is prohibited by FWC and is subject to enforcement by FWC if reported. All fishing requires a Florida fishing license which is available online by clicking here.

Please enjoy the summer whether it's here in the Plantation or some other wonderful locale!

IMPORTANT SAND FENCING GUIDELINES FOR BEACHFRONT OWNERS

Dune fencing and vegetation are required for all beachfront properties, including new construction. No work on dunes/beaches is allowed during turtle season (May 1 - Oct 31). BOARD BRIEFS AND COMMUNITY NOTES

Treasurer: Robin Cooper, Treasurer; The Investment Committee has approved Patrick Roffey as a member. The Board agreed with the Investment Committee's recommendation presented by Robin Cooper, Treasurer, that the Board open the Schwab account and engage Marco Investment Management to purchase US T-Bills ranging from 3 - 9 months on an ongoing basis.

General Manager: Brenda Ash, General Manager; The Board has amended the Meeting Recordings Resolution to include all committee meetings. Recordings will be available for 90 days after the meeting. Jane Kirk, the Association's Owner & Communication Liaison, will sadly retire this June. She has provided invaluable service over seven years and will be greatly missed. The administrative office has a new addition, Sonya Thompson-Shuman, who will be Administrative Security Support since Jaylynn Boone will be transitioning to the Owner & Communication Liaison along with her continued role as ARC Liaison.

Security: Bob Shiver, Director of Security; The Board approved three (3) citations regarding ARC violations to go before the Compliance Committee for fining. The Committee will meet within the upcoming weeks. Security is gearing up for a busy Summer season and staying proactive during turtle season.

Facilities: Philip Square, Facilities Manager; Summer maintenance routine is underway, with the mowing of all roads being scheduled bi-weekly, along with the weekly mowing of the scenic areas. The maintenance team re-decked the Resort Village Clubhouse back entry, adding a step to make it easier to use. Dan Garlick, project manager for the RV dock, reported that once the remaining pilings are sourced, the dock would be finished in an estimated 2-week time frame.

ARC: Tim Thompson, Chair; With a 4 to 2 vote, the Board approved the presented New Home Construction Process concept as a package. It will go back to the ARC Committee to submit a definitive version to the Board at a future meeting. The Board also approved adding the sand fencing requirement to the final beachfront new home construction inspection checklist.

Finance: Robin Cooper, Chair; The Board agreed with the Committee's recommendations to retain the 3-year effective surplus of 195K in the operating fund account and establish an Ad-Hoc Committee to review the legal financial and practical reform of the visitor entrance fees and make a final proposal to Finance Committee.

Infrastructure: August Elliott, Chair; The Board agreed with the Committee's recommendation that the following roads be re-paved in 2024: Acacia, Avocet, Azalea, Denise Court E, Denise Court W, Denise Drive, Jasmine Way, Jasmine Way T, Kumquat Court, Kumquat Court T, Long Point Rd., Palmetto Way, Sea Oat, Twisted Pine, and Sea Fern Way. The Board also agreed with the Committee's recommendation to replace the Magnolia Clubhouse generator and accept the lower bid from Cox Pools for resurfacing the Magnolia pool.

SHARING BEACHES WITH SEA TURTLES



What You Can Do To Help:

- Leave no trace
- Fill in holes
- Let them be
- Keep it dark





Great reminders for turtle nesting season! The nesting season runs from May 1 - October 31. Help educate others with these tips:

Leave No Trace - Take all of your belongings with you when you leave the beach, especially trash and beach furniture which might stop a sea turtle from nesting.

Fill In Holes - Always fill in your holes at the end of the day so nesting females and hatchlings have a flat beach to crawl on. Keep it safe for humans too!

Let Them Be - If you see a nesting female or a hatchling sea turtle, keep your distance and allow them to crawl to the sea on their own.

Keep It Dark -Sea turtles can be disoriented by bright lights on the beach. Keep blinds drawn, use sea turtle friendly lighting on beach front properties, and turn flashlights off on the beach at night. www.seaturtlelighting.net

Adding to the ambiance of the evening, guitarist Dr. Christopher Mrofchak entertained the party-goers with classical Spanish music.


With the sangria, paella, and guitar music, it felt like a little trip to Spain without leaving our beloved island.

New Website, New Owners Portal, Now What?

The long awaited and mobile friendly Plantation website, developed by KMA of Mexico Beach, FL, recently launched. The new Website (www.sgpoa.com) has all the same information as the old website and is mobile friendly and more user-friendly.

In addition to the public Website, a new owners portal is powered by FrontSteps, a software company specializing in HOA communities. Within the portal, owners can access SGPOA documents, meeting information, and Community information, including newsletters, bulletins, activities, etc. that is not public information.

The following steps are needed to access the **Owners Portal**:

• Owners should have received an email invitation (see above, right) from FRONTSTEPS to register. The *i*nvitation was sent to the email address on file. Please check your spam or junk folder if you did not receive the email. Contact office@sgpoa.com as soon as possible if your email needs to be updated in our records. Your directory information from the previous website did not transfer over.

Registering is required to access the Owners' Portal. You will need an email address and create a password requiring at least one capital letter, one number, and one non-alphanumeric character (!,@,# etc.)

To include your phone number and email information in the directory, you must "opt in".

Go to settings in the upper right-hand corner and click Privacy Settings. Check the corresponding box if you want emails, phone numbers, etc., visible in the directory.

Once registered, you can access FRONTSTEPS via the new Website www.sgpoa.com. The Owners Login button, located at the top right of the Home page (see photo above), will take you directly to the Owners' portal, FRONTSTEPS.

To enter guests: GATE PASS (for guest/vendor passes) is found in two places on the SGPOA Home page. Look for a portal button at the bottom right of the new SGPOA website Home page or in the top menu bar click LIVE (see photo above for menu bar) for a drop down menu, then click GATE PASS to access the Dwelling Live portal. Dwelling Live login information has not changed. Please do not call the gate to register guests.

***Please note: The Owners portal and the new Website are a work in progress. There will be changes and additions daily. Please check back frequently and inform the office of helpful changes or updates.
