

Maintenance Updates





The maintenance crew is hard at work giving St. George Plantation's common areas a fresh, welcoming glow for the upcoming Owners' Weekend! They're painting curbs and fences, installing shiny new signs, mowing, trimming, and sprucing up the landscaping to make everything look spectacular.



Improvements include:

- Putting down pine straw in common areas including the front entrance, Pelican Point tennis court, Resort Village road entrances, pool area, and cul-de-sacs, areas along Leisure Lane, the Magnolia Clubhouse area and the airport next to the airport lounge.
- Trimming of the bike trail between Magnolia Road and Forsythia Court to prepare for the Fun Run.
- Blowing off tennis courts and pickleball courts prior to Owners' Weekend.
- Painting curbs at entrance.
- Painting fence between tabby poles at the entrance.
- Cleaning rust stains at the entrance.
- Installing new signage at the entrance to replace stained signs.

Pirates, Native Americans & Explorers

The history of <u>St. George Island</u> is colored with pirates, Indians and shipwrecks. The Creek Indians first inhabited the island as early as the 1600s. The Indians were aggressive traders and commerce flourished from the St. Marks River around and up the Apalachicola River.

The arrival of the Europeans to the island was followed by intensive struggles for control of the area. Pirate Captain William Augustus Bowles led the Creek Indians in their defense against the Spanish and

French in the late 1700s. Legend has it that before Bowles died he buried a treasure somewhere on the island.

After the Forbes Purchase in 1803, commercial sailing traffic increased and a lighthouse was built on the west end of the island, which is now Little St. George Island. Following years of coastal erosion, the Cape St. George Lighthouse toppled into the Gulf in 2005. It has been rebuilt by lighthouse enthusiasts in its present location in the center of the St. George Island business district. It is the centerpiece of the island's Lighthouse Park along with the Keeper's Museum.

Furthermore, as I have been a long-term resident, I do have extensive institutional knowledge which is often called into play by newer board members. - Fairness & Collaboration Respecting every member's voice and restoring unity across the Plantation

Ingredients:

- 1 Tbs. olive oil
- 1/2 cup chopped yellow onion
- 2 minced garlic cloves (or 1 ½ tsp. garlic powder)
- 21/2 cups low-sodium chicken broth
- 2-4 oz. cans diced green chilies
- 1/2 tsp. ground cumin
- 1/4 tsp. cayenne pepper
- 1/2 tsp. dried oregano
- 1/2 tsp. paprika
- 1/2 small lime (juice only)
- Salt & fresh ground black pepper to taste
- 2-15 oz. cans great northern beans
- 1 cup sour cream or plain Greek yogurt
- 1 cup corn (frozen or fresh)
- 2 heaping cups cooked chicken, shredded (rotisserie or left-over chicken)



Suggested Toppings:

- Fresh cilantro
- Shredded cheese
- Tortilla chips
- Green onions
- Avocado

Instructions:

- Heat olive oil in a large (5-6 quart) pot over medium-high heat. Add onion and sauté until softened, 3-5 minutes. Add garlic and cook for 30 seconds.
- Add chicken broth, green chilies, cumin, cayenne, paprika, oregano, lime juice and season with salt and pepper to taste.
- Drain and rinse beans in a strainer.
- Measure out a big ladleful of the beans and add to a food processor with a splash of broth from the soup. Puree until smooth (This step is optional but helps to yield the creamy and thick texture we want from this chili!).
- Add pureed beans, whole beans and corn to the soup pot. Bring the mixture to a simmer and cook, uncovered, for 15 to 30 minutes.
- Remove from heat and stir in sour cream and cooked chicken.
- Serve garnished with cilantro, shredded cheese, avocado slices and tortilla chips if desired.






